



What is “Protecting America Now?”

The 501(C)(4) organization Protecting America Now supports the successful appointment and tenure of Scott Pruitt as Environmental Protection Agency administrator. The Mission of the organization is to restore the EPA to its original intent through smart, certain regulation that protects the environment and creates job.

What is a “501 (C)(4)” – what can it do and not do?

501(c)(4) organizations may engage in political lobbying and political campaign activities.

Who can give to *Protecting America Now* and what are the limits?

Protecting America Now is permitted to accept unlimited contributions from individuals, corporations, partnerships, and any other source. Donations are not deductible as charitable contributions for federal income tax purposes or as a business expense pursuant to IRC section 162(e).

Are contributions to *Protecting America Now* disclosed publicly?

No. 501(c)(4) organizations are required to disclose certain information publicly, however, according to the IRS, "with the exception of private foundations, an exempt organization is not required to disclose the name and address of any contributor to the organization."

How will the money be used?

The Mission of the organization is to restore the EPA to its original intent through smart, certain regulation that protects the environment and creates job.

Our current project is an important one—EPA Administrator. EPA can do better, and will do better if Scott Pruitt is confirmed as EPA administrator by the U.S. Senate. However, Mr. Pruitt’s confirmation is not a certainty. It may prove to be the most difficult presidential appointment due to environmental extremist opposition. Anti-business, environmental extremists have mobilized to spend millions opposing Pruitt’s appointment because they see it as their best, most immediate chance to derail a Trump appointment.
