Wednesday, July 19, 2017 at 11:30 AM EDT

- Secretary Perry (SRP) spoke with Prime Minister Volodymyr Groysman (PMG) of Ukraine by telephone. Secretary Perry was reliant on the GOU translator and did not have an American translator to assist with the call. The GOU translation was not at an acceptable level for clear understanding of the questions and the entire phone conversation.
