

Count 1

The Grand Jury of said county charge that, before the finding of this indictment, ONIS GLENN III, whose name is to the Grand Jury otherwise unknown, with the intent to promote or assist the commission of the offense, did aid or abet a public official, to-wit: WILLIE S. PHILLIPS, JR., Commissioner of the ALABAMA ENVIRONMENTAL MANAGEMENT COMMISSION, to intentionally use or cause to be used the official position and/or office held by WILLIE S. PHILLIPS, JR. to obtain personal gain to-wit: compensation from DRUMMOND COMPANY, INC., for WILLIE S. PHILLIPS, JR., a family member of WILLIE S. PHILLIPS, JR. and/or a business with which WILLIE S. PHILLIPS, JR. is associated and said use and/or gain is not otherwise authorized by law, in violation of Section 36-25-5(a), of the Code of Alabama, against the peace and dignity of the State of Alabama.

Count 2

The Grand Jury of said county charge that, before the finding of this indictment, ONIS GLENN III, whose name is to the Grand Jury otherwise unknown, with the intent to promote or assist the commission of the offense, did aid or abet a public official to-wit: WILLIE S. PHILLIPS, JR., Commissioner of the ALABAMA ENVIRONMENTAL MANAGEMENT COMMISSION to intentionally solicit or receive a thing of value as described under Section 36-25-1 of the Code of Alabama, to-wit: compensation from a principal, to-wit: DRUMMOND COMPANY, INC., in violation of Section 36-25-5.1(a), of the Code of Alabama, against the peace and dignity of the State of Alabama.

Count 3

The Grand Jury of said county charge that, before the finding of this indictment, ONIS GLENN III, whose name is to the Grand Jury otherwise unknown, with the intent to promote or assist the commission of the offense, did aid or abet a public official to-wit: WILLIE S. PHILLIPS, JR., Commissioner of the ALABAMA ENVIRONMENTAL MANAGEMENT COMMISSION to intentionally solicit a thing of value to-wit: compensation, other than in the ordinary course of business, from a business with whom he directly inspects, regulates, or supervises in his official capacity, to-wit: DRUMMOND COMPANY, INC., in violation of Section 36-25-5 (e) of the Code of Alabama, against the peace and dignity of the State of Alabama.

Count 4

The Grand Jury of said county charge that, before the finding of this indictment, ONIS GLENN III, whose name is to the Grand Jury otherwise unknown, with the intent to promote or assist the commission of the offense, did aid or abet a public official to-wit: WILLIE S. PHILLIPS, JR., Commissioner of the ALABAMA ENVIRONMENTAL MANAGEMENT COMMISSION to intentionally solicit or accept a thing of value, to-wit: compensation from Drummond Company, Inc., a business regulated by AEMC, while associated with the regulatory body, to-wit: Alabama Environmental Management Commission other than in the ordinary course of business, in violation of Section 36-25-12, of the Code of Alabama, against the peace and dignity of the State of Alabama.

Count 5

The Grand Jury of said county charge that, before the finding of this indictment, ONIS GLENN III, whose name is to the Grand Jury otherwise unknown, with the intent to promote or assist the commission of the offense did aid or abet a public official or public employee, to-wit: WILLIE S. 


