A BILL

To reauthorize the diesel emissions reduction program, and
for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Diesel Emissions Re-
5 duction Act of 2019”.

6 **SEC. 2. REAUTHORIZATION OF DIESEL EMISSIONS REDUC-**
7 **TION PROGRAM.**

8 Section 797(a) of the Energy Policy Act of 2005 (42
9 U.S.C. 16137(a)) is amended by striking “2016” and in-
10 serting “2024”.

1 **SEC. 3. RECOGNIZING DIFFERENCES IN DIESEL VEHICLE,**
2 **ENGINE, EQUIPMENT, AND FLEET USE.**

3 (a) NATIONAL GRANT, REBATE, AND LOAN PRO-
4 GRAMS.—Section 792(c)(4)(D) of the Energy Policy Act
5 of 2005 (42 U.S.C. 16132(c)(4)(D)) is amended by insert-
6 ing “, recognizing differences in typical vehicle, engine,
7 equipment, and fleet use throughout the United States”
8 before the semicolon.

9 (b) STATE GRANT, REBATE, AND LOAN PRO-
10 GRAMS.—Section 793(b)(1) of the Energy Policy Act of
11 2005 (42 U.S.C. 16133(b)(1)) is amended—

12 (1) in subparagraph (B), by striking “; and”
13 and inserting a semicolon; and

14 (2) by adding at the end the following:

15 “(D) the recognition, for purposes of im-
16 plementing this section, of differences in typical
17 vehicle, engine, equipment, and fleet use
18 throughout the United States, including ex-
19 pected useful life; and”.

20 **SEC. 4. REALLOCATION OF UNUSED STATE FUNDS.**

21 Section 793(c)(2)(C) of the Energy Policy Act of
22 2005 (42 U.S.C. 16133(c)(2)(C)) is amended beginning
23 in the matter preceding clause (i) by striking “to each re-
24 maining” and all that follows through “this paragraph”
25 in clause (ii) and inserting “to carry out section 792”.
