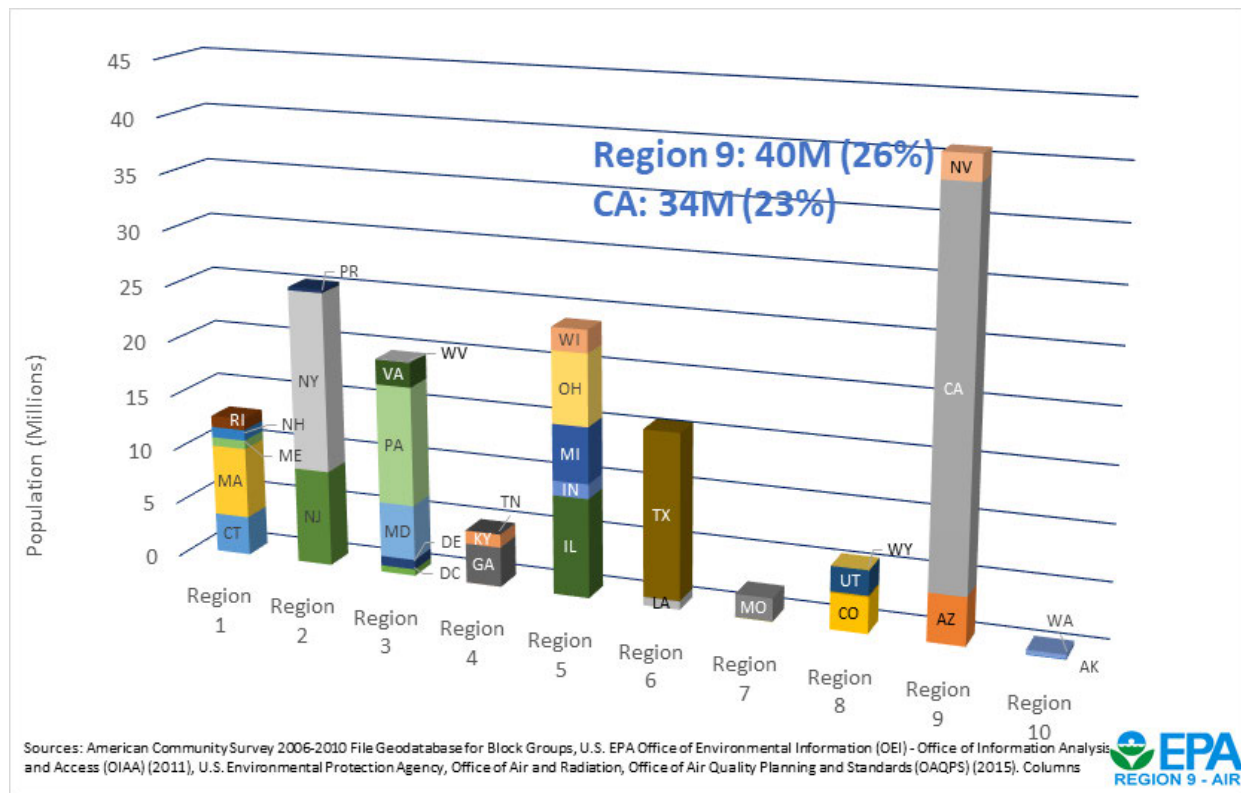

Here is the statement from OAR Communications. Clint is reviewing it now, but if you see anything glaringly wrong, let me know. [REDACTED]

Summed across standards, California had -- by EPA's count in early August -- 82 non-attainment areas. This number takes into account that California has multiple areas that are not meeting several standards. For example, some areas are simultaneously not meeting four ozone standards (1979, 1997, 2008, and 2015), while also not meeting four PM2.5 standards (1997 and 2006 24-hour, 1997 and 2012 annual).
